COUNT 2) And the District Attorney further gives the Court to understand and be informed that on or between March 5th and March 6th, the said **TERRANCE L. LEONARD** violated La.R.S.14:30 in that he did commit first degree murder of N.R. (DOB 8/27/2004), when the offender has a specific intent to kill or inflict great bodily harm upon more than one person,

COUNT 3) And the District Attorney further gives the Court to understand and be informed that on or between March 5th and March 6th, the said **TERRANCE L. LEONARD** violated La.R.S.14:30 in that he did commit first degree murder of A.R. (DOB 02/02/2009), when the offender has a specific intent to kill or inflict great bodily harm upon more than one person and when the offender has the specific intent to kill or inflict great bodily harm upon a victim that is under the age of twelve,

COUNT 4) And the District Attorney further gives the Court to understand and be informed that on or between March 5th and March 6th, the said **TERRANCE L. LEONARD** violated La.R.S.14:30 in that he did commit first degree murder of D.E. (DOB 03/24/2009), when the offender has a specific intent to kill or inflict great bodily harm upon more than one person and when the offender has the specific intent to kill or inflict great bodily harm upon a victim that is under the age of twelve,

contrary to the form and Statute of the State of Louisiana, and against the peace and dignity of the State.
