COUNT 2) And the District Attorney further gives the Court to understand and be informed that on or about October ~~22nd~~, *21st* 2020 the said JUSTIN A. HUTCHINSON violated La.R.S. 14:130.1 in that he did obstruct justice by tampering with evidence with the specific intent to distort the results of a second degree murder investigation by removing evidence from the scene of the crime,

COUNT 3) And the District Attorney further gives the Court to understand and be informed that on or about October ~~22nd~~, *21st* 2020 the said JUSTIN A. HUTCHINSON violated La.R.S. 14:95.1 in that he did have in his possession a 9 MM firearm, having been previously convicted of the crime of Aggravated Assault with a firearm, on February 2, 2015, in violation of La.R.S. 14:37.4, under case number 13-3121, Division "N" in the 24th Judicial District Court,

COUNT 4) And the District Attorney further gives the Court to understand and be informed that on or about October ~~22nd~~, *21st* 2020 the said JUSTIN A. HUTCHINSON violated La.R.S. 14:95.1 in that he did have in his possession a .40 caliber firearm, having been previously convicted of the crime of Aggravated Assault with a firearm, on February 2, 2015, in violation of La.R.S. 14:37.4, under case number 13-3121, Division "N" in the 24th Judicial District Court,

contrary to the form and Statute of the State of Louisiana, and against the peace and dignity of the State.
