COUNT 4) And the District Attorney further gives the Court to understand and be informed that on September 4, 2019 the said **MALIK B. MCGINNIS AKA "RK"** violated La.R.S. 14:27:30 in that he did attempt to commit the first degree murder of Juwan Magee,

COUNT 5) And the District Attorney further gives the Court to understand and be informed that between September 4, 2019 and September 5, 2019, the said **MALIK B. MCGINNIS AKA "RK"** violated La.R.S. 14:130.1 in that he did obstruct justice by tampering with evidence to wit: by removing the .38 caliber revolver, he used to shoot the victims, off of the crime scene, and/or getting rid of the jacket he was wearing at the time of the murders knowing that it would be evidence in this murder investigation,

COUNT 6) And the District Attorney further gives the Court to understand and be informed that between September 4, 2019 and September 5, 2019, the said **EVERETTE CAMPBELL AKA "KR"** violated La.R.S. 14:130.1 in that he did obstruct justice by tampering with evidence to wit: by removing a firearm he possessed on the crime scene and discarding it, and/or trying to get rid of the fired .38 caliber cartridge casings fired from the murder weapon, and/or getting rid of the clothing he was wearing at the time of the murders knowing that it would be evidence in this murder investigation,

COUNT 7) And the District Attorney further gives the Court to understand and be informed that on September 5, 2019 the said **EVERETTE CAMPBELL AKA "KR"** violated La.R.S. 40:966.A in that he did knowingly or intentionally cultivate a controlled dangerous substance, to wit: Marijuana weighing less than 2.5 pounds,
